Further, an assessment of the Company's capital, financial resources, liquidity positions, and other financing arrangements for the next one year, indicates financial stability. An evaluation of impact of COVID-19 on internal financial controls over financial reporting concluded that there is no impact of COVID-19 thereon. There is no materially adverse impact of COVID-19 on the financial statements/results of the Company for the financial year ended March 31, 2020.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid Statement:

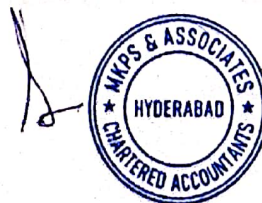
- (i) is presented in accordance with the requirements of Regulation 33 of the Listing Regulations in this regard; and

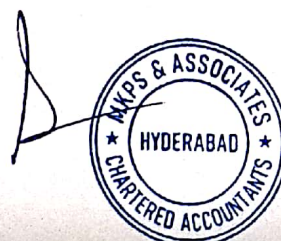
The Board of Directors of the Company are responsible for overseeing the financial reporting process of the Company.


